

ORDINANCE NO. 221

AN ORDINANCE ANNEXING EAGLE RIDGE AT PINEBROOK, MEADOW WILD, SNYDER'S MILL PLAT 1 AND 1A, AND SOUTH SHORE AT SILVER SPRINGS PLATS B AND C SUBDIVISIONS INTO SUMMIT COUNTY SERVICE AREA NO. 6

WHEREAS, the Summit County Board of Commissioners as the governing authority of Summit County Service Area No. 6 heretofore resolved to annex certain residential subdivision areas into Summit County Service Area No. 6 for the purpose of providing road maintenance, including snow plowing, within said subdivisions; and,

WHEREAS, pursuant to the provisions of U.C.A. 17A-2-401 et seq. the Summit County Board of Commissioners published notice of their intent to annex said subdivisions into Summit County Service Area No. 6 and held a public hearing concerning such proposed annexation; and,

WHEREAS, neither owners of land within the subdivision properties proposed to be annexed nor registered voters residing therein objected or protested annexation of said subdivisions to Summit County Service Area No. 6;

NOW, THEREFORE, it is hereby ordained by the Board of County Commissioners of Summit County, Utah:

SECTION I. Summit County Service Area No. 6 is hereby expanded to include the following named subdivision properties, all of which are particularly described and platted residential subdivisions recorded in the office of the Summit County Recorder:

1. Eagle Ridge at Pinebrook
2. Meadow Wild Subdivision
3. Snyder's Mill Subdivision, Plat 1 and 1A
4. South Shore at Silver Springs, Plate B
5. South Shore at Silver Springs, Plat C

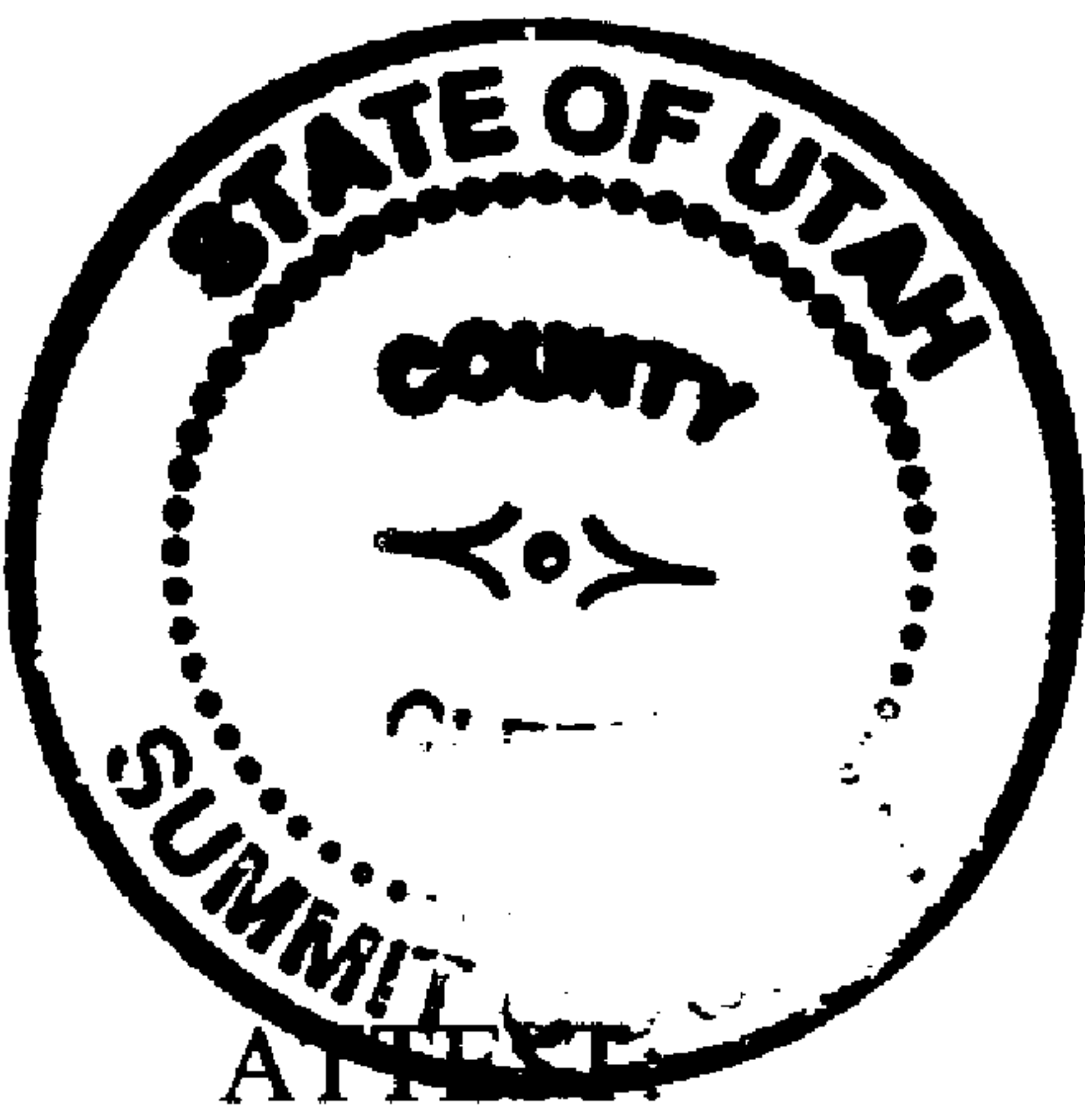
