SUMMIT COUNTY BOARD OF COMMISSIONERS REGULAR MEETING HELD JULY 6, 1982

Coalville, Summit County, State of Utah, the Board of County Commissioners met in regular session Tuesday, July 6, 1982, and the following business transacted:

Prayer was offered by Commissioner Gerald Young.

Minutes of June 29, 1982 were read and upon the motion of Commissioner Gerald Young to make one correction on the 1982 mill levy statement, to read the County Commissioners felt that at the hearing the mill levy was already set according to the State law, therefore they could not be allowed to receive more than the \$975,000.00 this year. This correction was made and Commissioner Ovard seconded the approval of the minutes. All voted in favor.

Animal Control

Sheriff Ronald Robinson and Berry Shoda of the Animal Control Department presented to the Commissioners problems that have confronted them. They reported that some dogs have been poisoned in the Silver Creek area.

Berry had a number of citations that he had written on animal complaints and that were to be taken care of in Judge Kilby's court; but Judge Kilby just dismissed them.

Mr. Reed Pace is to call Judge Kilby and set up a meeting for him to meet with the Commissioners on this problem. Also, Terry Christiansen, Robert Adkins, and Sherrif Robinson are to be at this meeting.

Escrow Release - Silver Springs Plat 1A and 1B

Stan Strebel brought in a copy of Amended Declaration of Covenants which indicates that the Homeowner's Association would be responsible for perpetual maintenance of the underdrain system in Silver Springs Subdivision. Also presented was an agreement between Silver Spring Development, the Homeowner's Association, and Summit County clarifying the maintenance responsibilities of the Homeowner's Association.

Commissioner Young made the motion to release from the escrow account on Plat 1A \$90,000. and from the escrow account of Plat 1B \$104,255.00 with a remaining amount of \$5,000.00. Commissioner Wallin seconded the motion. All voting in favor.

Kamas Dump

Stan Strebel also presented bills on the Kamas Dump. He was advised to send a copy of these bills to the Kamas Town Board.
