By- Laws of Silver Springs Homeowner's Association

AMENDMENTS

On the 19th of October 1987, a meeting of the Members of the Silver Springs Homeowner's Association was held at Parley's Park Elementary School in Snyderville, Utah. A quorum was present at this meeting, and after the giving of notice that such would be considered, the following amendments to the By-Laws of Silver Springs Homeowner's Association * dated 31st October 1985, and recorded in the office of the Summit County Recorder, State of Utah, as Entry No. 244976, in Book 370, at Pages 276-" By-Laws") were considered and 288, (hereinafter referred to as approved by a majority of the Members.

The language of Article I, page 1 of the By-Laws was amended by deleting the last sentence..... "The office of the Registered Agent of Association shall be located at 175 West 200 South, Suite 4004, Salt Lake City, Utah.

And to be replaced with..... "The office of the Registered Agent of Association shall be located at P. O. Box 3323, Park City, Utah 84060."

The language of Article III Section 5. Quorum, page 3 of the 8y-Laws was amended by deleting..... "In the absence of a quorum, the meeting shall be adjourned for twenty-four (24) hours...."

And to be replaced with "In the absence of a quorum, the meeting shall be adjourned, then re-convened within 30 days, allowing Members at least two weeks notice of meeting and providing proxy forms,....." * *

The language of Article IV Section 2. Term of Office. Page 4 of the By-Laws was amended by deleting..... for a like term of years."

To be replaced with...... "..... All Trustees elected to office will serve for a term of two (2) years. Annual elections to alternately install four Trustees one year and three Trustees the next year, etc." 525ma668 -669

The language of Article VIII Section 2. Election of Officers. Page 7 of the By-Laws was amended by deleting......".....one (1) year......".

To be replaced with.....".....two (2) years......"
