SUBJECT: SILVER SPRINGS MAILBOXES

They're available now! The Board of Trustees has at last found a reliable source for the construction and delivery of our most distinctive mailboxes to homeowners not presently so equipped. Below are some of the particulars:

- Built of solid rough-cut cedar.
- Treated two-foot-long wood post for secure and permanent planting.
- Pre-painted in required Castle Grey color (Cuprinol).

and include:

- Electrical wiring for required night lighting.
- Standard post office approved black mail box with red signal flag.
- Photo-electric light sensor for automatic turn-on and turn-off.
- Wooden parts securely screwed together (the original boxes were stapled).
- Translucent glass slide for box number.

These boxes are required per authority of our CC&Rs, and it will be necessary for all homes in our subdivision to have one.

If you have already constructed and installed a different style mailbox, we regret that these non-standard boxes must come down and be replaced by an approved model. Although there may have been some expense with these non-standard boxes, we think you will agree that the new boxes will add distinction and value to not only your home but the neighborhood in general.

If you were planning to build one yourself in your garage, please consider that the materials will cost you nearly as much as the price of the offered box and chances are your home-made box will not meet community standards.

Incidentally, new homes under construction after the date of this memo will be required to purchase one of these standard boxes as a pre-condition of plans approval.
