EMERGENCY ACTION PLAN

Silver Creek Ponds – Park City, UT

1.0 Introduction

The purpose of this Emergency Action Plan is to provide a guideline that should be followed during an emergency to maximize safety and minimize damage in the event of a dam failure.

2.0 Emergency Procedures

The outlets and spillways are designed to pass a very large amount of water and both the upper and lower ponds are equipped with emergency overflows that should channel excess water to the natural drainages. However, during an extreme rain or snowmelt event, the spillways and overflows could become plugged with debris causing possible flooding or failure of the dam. Monitoring of the dams should be conducted as outlined in the Standard Operations Plan to ensure their structural integrity.

Water levels should be monitored frequently during storm and snowmelt events. When the levels in the either pond reach an elevation one foot below the crest of the dam, emergency action should begin. Residents should be urged to evacuate the areas indicated on the inundation maps. The Emergency Notification List should be used to notify the correct emergency support agencies at this time.

In the event of a spontaneous dam failure, emergency personnel should be contacted. This would include the Park City Police Department and Park City Fire Department. The Park City Public Works Department should be called to offer assistance with equipment for repair and clean-up.

The State Engineers office should be notified as soon as possible after a failure or breach of the dam. The enclosed Emergency Notification List provides necessary emergency contact information.
