

- Unknown until 4 years ago (Anecdotal evidence of some random property and crawl space water) could be drains
- Significant crawl space water in lots along E. Meadows Dr./Property line drainage at SS Dr & Lake Ct
- Research "rediscovers" existence of drain system
- Commercial Roto Router clears significant root invasion into drain pipes. Crawl space water recedes - property line drainage stops

Problem history-

- Developer bonded for 3 years, then turned over to SSHOA (Evidence) ?
- "transient" flow from higher elevation off subsurface water (from ground snow melt & protect properties and utilities. Intercept & drain
- Well known "high water table" area
- 1979/1980 initial development, County required

Why is it here?

- Drains into Willow Creek
- Silver Springs 1A/1B (Maps)
- 3 1/2' w X 8-12' d access/junction man holes (many hidden)
- 6-10" corrugated, flexible, French drain pipe
- 8-10' deep trenches

- Who legally "Owns" the system
 - Effectiveness of HOA maintenance of system unknown
 - Many manholes landscaped or paved over
 - "Ground truth" vs maps
 - Where most lines and access man holes really are
 - Root obstructions/ground shift pipe collapse
 - Health of system (near/at design life)?
 - Extent of subsurface water invasion into other properties of Silver Springs
 - If water in crawl spaces is result of pipe obstructions, overcapacity, "other" water moving through ground, or a combination of the three
- What we don't know-
- High potential for additional problems if system is not maintained
 - The system underlies the entire subdivision
 - Where immediate problems have surfaced/recurred
- What we know-
- Unable to reach entire part of system behind E. Meadows
 - Periodic clearing seemed to work until this spring, when significant ground water returned to lots along E. Meadows

-- Incomplete/Missing legal documentation

-- County denies ownership

What does this mean for the SSSFHOA?

- High potential for future system related problems

-- No known maintenance from inception until 2004

- If SSSFHOA "owns" the system *SSD, Inc "owns" 1979*

-- Repair/Maintenance costs

-- Legally liable for damage caused by defects

--- How is cause of underground water damage to property assigned to failure of the drain system?

- Lot owners responsibility in CC&RS

-- '5' easement/do nothing to cause flow restriction/obstruction

What we need to do-

- Determine legal "Ownership" of system

-- County/Developer/SSFHOA

-- If County or Developer

---Sue if necessary to enforce responsibility, or

--- SSSFHOA assume responsibility, legal release from homeowners for liability

-- If SSSFHOA "Owns"

--- Insurance for liability (similar to Lakes?)

lakes) ?

--- Contract with Geotechnical company for proposal (\$\$\$)

---- 1) Provide proposal with solutions for immediate known problem area along E. Meadows Dr./SS Dr.-Lake Ct

---- 2) Possible follow-on for other system problems that are not now known

Results of preliminary contact with two geotech firms

- Clear out fall restriction/back pressure/Willow Creek
- Work upstream from out fall to determine viability of existing system
-- Roto Route/camera/back hoe

- Only when system integrity is verified can it be determined if overcapacity or other circumstances are causing the water to enter crawl spaces
- or if drain system is the only culprit
- Survey residents to get a picture where else there is a problem (if any)

DECISION

- Do we pursue legal definition of "Ownership"?
-- Potential court fight with County/Developer(\$\$\$)
- If not, proceed with engineering firm selection
- Appoint "Under drain Committee" to work under direction of HOA
