FIRST AMENDMENT TO SILVER SPRINGS SINGLE FAMILY HOA BY-LAWS

In accordance with the existing and applicable By-laws, the Silver Springs Single Family HOA hereby amends its By-laws, which were duly recorded on January 16, 1986, as Entry No. 244976, Book No. 370, Pages 276-288, as follows:

The first sentence of Article III, Section 2 of the current By-laws shall be amended from:

The annual meeting of the Members shall be held on the second Monday in October, at the hour of 7:00 o'clock, p.m.

to now read:

The annual meeting of the Members shall be held on the second <u>Tuesday</u> in October, at the hour of 7:00 o'clock, p.m.

Article V, Section 1 of the current Bylaws shall be amended to now read:

Section 1. Nomination. Nomination for election to the Board of Trustees shall be made by a Nominating Committee, except for the first reorganization meeting when the nominations shall be made by the Steering Committee. Nominations may also be made from the floor at the annual meeting. The Nominating Committee shall consist of a Chairman, who shall be a Trustee, and two or more Members. The Nominating Committee shall be appointed by the Board of Trustees prior to each annual meeting of the Members, and such appointment shall be announced at each annual meeting. The Nominating Committee shall make as many nominations for election to the Board of Trustees as it shall in its discretion determine, but not less than the number of vacancies that are to be filled. All nominees must be members in good standing.

All other existing Bylaws shall remain in full force and effect other than to the extent there is a conflict between these amendments and the existing By-laws, the amendments shall apply.

Rewrite to read: A majority of the Board of Trustees present in person, no fewer than three (3), and/or represented by formally signed proxies at a special or regularly scheduled meeting shall constitute a quorum for transacting official Silver Springs Single Family Home Owners Association Board of Trustees business.

Article VIII. Officers and Their Duties.

Section 2. Election of Officers. End of Line 3, drop "be" following "or shall" and add: "choose not to seek or fails reelection, preventing fullfilment of a two-year term."

Section 8. President. Line 6. Add following "Board" the words: "and give formal, timely notice of such meetings.".

Section 10. Secretary. Line 3. Following word "direct," delete words "keep the corporate seal and affix it on all papers requiring said seal; serve notice of meetings of the Board and of the Members".

Section 11. Treasurer. Line 1. Provide space between words "Treasurer" and "shall."

Line 4. Following word "shall" add words "cause to be" and to the word "prepare" add letter "d". Line 6. Substitute for "membership at its regular meeting" words "board of trustees for eventual approval and adoption."

Article X. Eliminate reference to "Corporate Seal."
