- \* Tennis Court: Robyn reported that this year the HOA installed a new crank on the courts, we welded the gate, put new gravel on the walks and playground bark in the play area.

they did move nearly 40 native large trout down to the Big Lake before they drained the Little Lake.

- New Beach Area: Gaylynn reported that we installed a new beach area out in the peninsula area where people can bring and lock up there canoes, and kayaks. There has been a lot of use and it is nice to use that area. Robyn also reported that the North Shore entrance now has a safer trail that connects to the peninsula. It was completed in the spring.
- Signs: We have installed all new signs on the association property that better reflect what our rules and regulations are for these areas.
- Re-writing Documents: Bill Noland explained that our documents are out of date.
  We are updating them with six additional properties. We may consider changing our
