Approval of Prior Meeting Minutes

- 2. *CC&R Compliance* Mark Buford (PMA) gave the compliance report for the absent Rose Carriel, Chair of the Compliance Committee. Mark discussed ongoing compliance issues and suggested sending semi-annual reminders to all members about common ongoing compliance issues, particularly RVs, boats and other recreational vehicles stored for longer than 4 days.
