*Silver Springs Masters HOA

*Architectural Review Committee

Steve Fassett, Chair, reported on ongoing renovations/additions, including an application for variance for solar panel installation at 5148 East Meadows Drive. The variance application was denied due to the visual impact from the street of: 1) the unusually large roof area involved, 2) the significant color contrast between the light brown roof shingles and the dark charcoal/black solar panels and 3) the large number of solar panels proposed, massed all together on one large roof section.

Request for variance for fence at 5129 Silver Springs Road – variance was approved unanimously.

*Codes, Covenants, and Restrictions (CC&R) Rewrite Committee – Brian Zilvitis, Chair, reported on the status of the rewrite and its review by Morris Sperry, the law firm contracted to assist in the rewrite.
