**Election fraud**, **election manipulation**, **stuffing the ballot box**, or **vote rigging** are each illegal interference with the process of an election, whether by positioning of the board membership, increasing the vote share of the favored candidate, depressing the vote share of the rival candidates, or all of these. Technically the term 'electoral fraud' covers only those acts which are illegal, the term is sometimes used to describe acts which are legal, but considered morally unacceptable, outside the spirit of an election or in violation of the principles of democracy.
